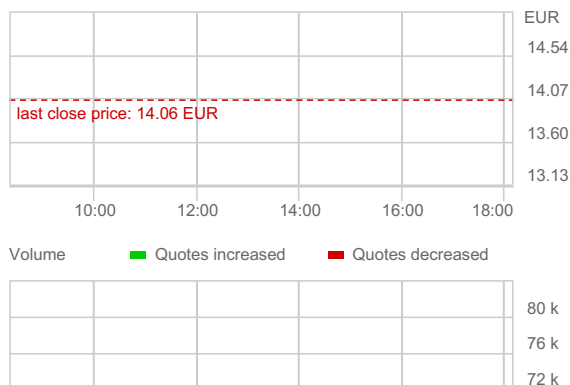

COMPANY PROFILE

Instone Real Estate is one of Germany's leading residential developers. The company develops attractive residential and multi-family buildings as well as publicly subsidized housing, designs modern urban quarters and refurbishes listed buildings for residential use. Buyers are mainly owner-occupiers, private investors and institutional investors. In 29 years, Instone Real Estate has successfully developed more than one million square metres. Around 375 employees work at nine locations nationwide. As of 31 December 2019, the project portfolio comprised 55 development projects with an expected total sales volume of roughly EUR 5.8 billion and around 13,715 units.

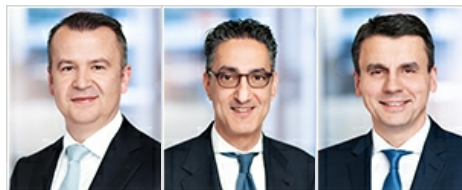
SHARE CHART
